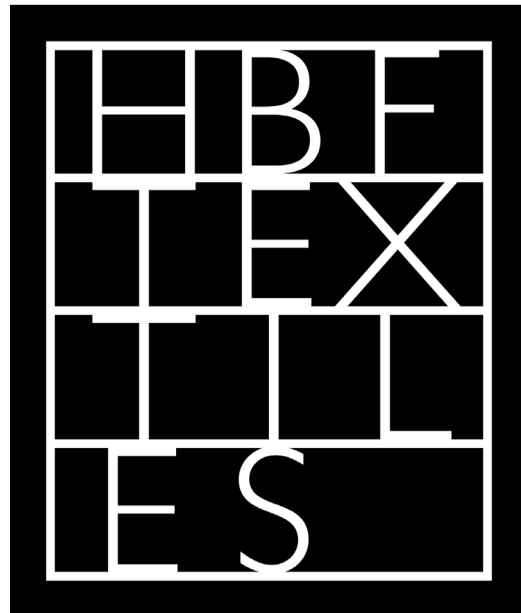

Ordering Information

All orders faxed and then mailed to HBF Textiles must be marked "Confirmation".
HBF Textiles will not be responsible for duplicate orders left unmarked.

All fabrics are sold in one-half (1/2) yard increments. There is a two (2) yard minimum per colorway per order.

All leathers are sold by the whole hide. There is a whole hide minimum per colorway per order. For additional half-hide requests, add a \$25.00 Net cutting fee. Due to the irregular size of hides exact square footage will fall within a tolerance of one-half hide.

Orders are subject to our acceptance with issuance of a formal order confirmation. Our order confirmation is final and binding. Any subsequent changes must be requested in writing and subject to our ability to incorporate the requested change.

Note: There will be a \$50.00 Net processing fee for orders that are requested to be processed and shipped the same day as received.

Terms of Payment

If credit has not been established, full payment, including shipping (see HBF Textiles Guaranteed Freight Program), must accompany the order. Credit may be established upon acceptance of satisfactory credit references. HBF Textiles also accepts MasterCard, Visa and American Express. When order is placed please provide account number, expiration date and name of card holder. Open account terms: NET 30 days, FOB Hickory, NC. HBF Textiles may cancel or change credit terms or may request a pre-payment at anytime.

Reserves

HBF Textiles will reserve fabrics for up to ten (10) working days upon request and intent to order. The reserve will delete on the tenth (10th) day at which time the fabric will become available for sale. Only one five (5) working day re-reserve is allowed.

Cancellations

Orders may not be cancelled without the written consent of HBF Textiles. If fabric has not been cut, cancellations are subject to a 20% handling charge. *No cancellations are accepted once the fabric has been cut.*

Returns

No returns will be accepted without written authorization. *Credit will not be issued unless the fabric is received on our premises within thirty (30) days from the date of the written return authorization.* Authorized returns will be subject to a 25% restocking fee and must be returned in a useable condition. *No returns will be accepted after merchandise has been cut.* Special order merchandise is not subject to return.

Samples

HBF Textiles will be pleased to send upholstery, leather and vertical material product samples upon request. The following items are available: 3x3 cuttings, chain sets, memo samples, leather products and vertical materials sample cards.

Because of natural variations in fibers, yarns, dyes, weaves and hides, samples may not match existing inventory. Dye lot samples will be sent upon request and receipt of order.

Special Finishes

Custom Fabrics

HBF Textiles has the resources to develop special colors in any of our standard patterns. HBF Textiles' designs can also be translated into other fiber combinations to accommodate pricing or special applications.

Upon receipt of order for custom fabrics a 50% deposit is required. Custom fabrics and/or special colors are sold by the full piece only (piece sizes vary according to mill). The customer is responsible for purchasing production overage (not to exceed 10% of the total yardage ordered).

On many discontinued items, yardage may still remain or a special order may be placed if piece minimum requirements are met.

Fabric Maintenance

HBF Textiles upholstery fabrics should occasionally be vacuumed to maintain their quality and appearance. For cleaning spots, consult a professional cleaning service. For cleaning of draperies, sheers and wallcovering, consult a professional cleaning service to obtain proper care and maintenance information.

Warranty

HBF Textiles does not warrant or guarantee any fabrics or goods it sells other than the continuing guarantees filed with the Federal Trade Commission under the Textile Fiber Products Identification Act and the Wool Products Labeling Act of 1939.

HBF Textiles is not responsible for dye lot variations or discrepancies in widths of fabrics. Fiber content and/or yarns may be substituted at our discretion. Sources and country of origin may be changed when deemed necessary without notification. HBF Textiles does not warrant, guarantee or represent an exact match to cuttings, memos or any samples.

In any event, HBF Textiles' responsibility will be limited to either replacement of merchandise or refund of purchase price at our option. Under no circumstances will HBF Textiles be responsible for any consequential damages, charges, costs, expenses or obligations.

HBF Textiles makes no warrant of merchantability or fitness for any purpose, either expressly or by implication.

Claims

All HBF Textiles are carefully inspected and securely packed prior to shipment from Hickory, NC. They are accepted as such by the carrier. Liability ceases as shipments are delivered to the transportation company. HBF Textiles is not responsible for damages incurred in transit or storage. Before accepting goods from the carrier, examine the shipment carefully. If there is any loss or visible damage to the containers, insist that a notation be made on the delivery slip. Claims for damage or loss must be filed immediately with the carrier. In case of concealed damage, you are protected if a claim is filed within five (5) days of delivery. Other claims against HBF Textiles for defects, errors or shortages must be filed with HBF Textiles in writing within ten (10) days of delivery. Failure to make such a claim shall constitute full acceptance of the yardage and waiver of all defects, errors or shortages. Cutting of the textiles will be deemed acceptance of the yardage and waiver of all defects, errors or shortages.
